



## **ARISTOCRAT ANNOUNCES CHIEF FINANCIAL OFFICER TRANSITION – TONI KORSANOS TO DEPART IN MARCH 2018 AS CFO ROLE RELOCATES TO LAS VEGAS**

"I deeply regret but fully respect Toni's decision not to relocate, and to instead embrace new challenges, progressing her executive career and pursuing her interest in non-executive directorships among other opportunities. I look forward to continuing to work closely with Toni in the months ahead, as we prepare for this important transition and maintain full momentum in executing Aristocrat's ambitious growth strategy" Mr. Croker concluded.
