On Friday, 31 March 2017, 33,000 ordinary shares held by PLHA Investment Trust were sold though the day in the course of regular trading at an average price of \$18.0413, reducing its holding to 2,540,000.

The purpose of the sale was for investment diversification and to reduce the burden of the regulatory compliance required by gaming regulators upon substantial shareholders.

The total of Aristocrat shares held in the various trusts controlled by Writeman Pty Ltd now totals 31,925,475 or 4.999 per cent of Aristocrat's total issued capital of 638,544,150 ordinary shares.
